





Selected grantees will receive \$500* to assist with expenses for travel to the 2017 Legislative Symposium, March 20th – March 21st, 2017 at the Hilton Alexandria Old Town in Alexandria, VA (http://www.ascls.org/education-meetings/legislative-symposium).

The grantees will be notified by February 10th, 2017.

To be considered for the grant, applicants must:

- 1. Be a current ASCLS Student member who has held membership for at least 3 months prior to the February 1st deadline.
- 2. Not be the Student Forum Chair, Vice-Chair, or Secretary.
- 3. Preference is given to those who have not attended an ASCLS Legislative Symposium before.

To receive the grant, grantees must:

- 1. Attend all educational events, including Congressional visits, at the Legislative Symposium.
- 2. Submit a 250-500 word summary of your experiences with pictures within 2 weeks of the end of the Legislative Symposium for the SF E-Newsletter.

It is expected that recipients will maintain their ASCLS Membership and provide active service at the local, state or national level after receipt of grant!

*\$250 will be given to applicant prior to the meeting and \$250 will be given at the meeting.
